MINUTE ORDER: Paragraph 1(e) of the court's Order [57] regarding Defendants' notice obligations provides that Defendants shall provide to Plaintiffs "at least 2 business days prior to the effective date of... (iii) its decision to authorize a use of a road or trail by a third party or BLM that was not permitted as of December 4, 2017... notice thereof and, within 2 business days after such decision is made, a copy of the decision, if any." Consistent with the court's ruling at the October 7, 2019 status conference, the court hereby clarifies that under this provision, Defendants are required to notify Plaintiffs of any contracts, permitting ground-disturbing activity, that had not been approved as of December 4, 2017. The court further clarifies that its September 30, 2019 Order [113] did not trigger the parties' obligations under Paragraph 7 of the Notice Obligation Order [57]. On or before October 25, 2019, the Government shall file a status report apprising the court of: (1) the number of ground-disturbing contracts that have been entered into after December 4, 2017; (2) whether Plaintiffs have been notified of those contracts; (3) whether there are any contracts about which Defendants object to providing Plaintiffs notice; and (4) whether Defendants object to providing Plaintiffs with retroactive notice of the precise locations (with GPS coordinates) of the routes already inventoried by Advanced Resource Solutions, including the dates that those routes were surveyed, and the type of vehicle used to inventory those routes. Plaintiffs shall file amended complaints on or before November 7, 2019. Upon the filing of Plaintiffs'

amended complaints, the parties shall meet and confer and file a joint status report proposing a briefing schedule. Signed by Judge Tanya S. Chutkan on 10/16/2019. (lctsc1)
