**ORDER**

On September 24, 2018, the court held a status conference to address Plaintiffs’ Unopposed Motion for a Status Conference (ECF No. 44) and other motions pending in *Hopi Tribe v. Trump*, Case No. 17-cv-2590, *Utah Diné Bikéyah v. Trump*, Case No. 17-cv-2605, and

*Natural Resources Defense Council, Inc. v. Trump*, Case No. 17-cv-2606. Consistent with the court's statements during the status conference, it is hereby ordered that:

1. Defendants shall provide Plaintiffs 48 hours' notice prior to any ground-disturbing activities within the Bears Ears National Monument's original boundaries. The parties shall submit a joint proposed order, detailing the specifics of the notice Defendants will provide, by October 8, 2018.
2. Defendants' Motions to Transfer (ECF No. 21, 17-cv-2590; ECF No. 19, 17-cv-2605; ECF No. 18, 17-cv-2606) are DENIED.
3. The parties shall meet and confer, and submit a joint proposed briefing schedule to address the three Motions to Intervene pending in *Hopi Tribe v. Trump*, 17-cv-2590, by October 8, 2018.
4. The Motion to Intervene (ECF No. 17) pending in *Utah Diné Bikéyah v. Trump*, 17-cv-2605, is GRANTED. The Motion for Admission Pro Hac Vice for Jeffrey W. McCoy (ECF No. 18) is also GRANTED.
5. Defendants shall file their anticipated Motion to Dismiss by October 1, 2018. Plaintiffs' response(s) to Defendants' Motion to Dismiss is due on November 1, 2018 and Defendants' reply in support of their motion is due on November 15, 2018.
