Making it harder to regulate toxics: The EPA – against concerns by career staff – recently released new policies and rules that will make it harder to regulate toxics. 	Legislation targeting new or existing safeguards – each of these has passed the House:
	H.R. 5; S.951: Would firmly tip the scales against the completion of any new safeguards. [NRDC, 1/10/17 (H.R. 5), 5/3/17 (S. 951)]
	<u>H.R. 26</u> : Would allow a single chamber of Congress to block any new safeguard, and as passed requires affirmative approval of <i>all</i> existing protections – any not approved would be eliminated by default. [NRDC, <u>1/4/17</u> ; E&E, <u>1/6/17</u>]
	<u>H.R. 998</u> : Would establish a commission to identify and offer for repeal any existing rules and safeguards, and require eliminating existing protections before establishing new ones. [E&E, 2/14/17]
