Californians Concerned About Fracking, Lack of Regulations

New polling shows that more than three-quarters of residents polled in California's 30th, 31st, 32nd, 43rd, and 58th assembly districts have concerns about fracking. Nearly half of residents polled in each district say their concerns are very serious. More than 75% of respondents in each district also have concerns about the lack of regulation of fracking in California, and more than half of Republican respondents in each district share these concerns.

Residents want more information and regulations first; in three districts -30, 43, and 58 - more than half of respondents support a moratorium on fracking until then. In District 31, 47% of respondents support a moratorium, while 43% support it in District 32.

Across all five districts, a clear majority said it was very important for their assembly member to vote to protect communities from potential threats from fracking to California's air and water.

Strong majorities in all districts supported a requirement for fracking companies to notify the state and nearby property owners before they begin an operation. Respondents showed an even stronger desire – over 80% in all districts – to require fracking companies to test groundwater for chemicals before and after fracking to protect groundwater from pollution. Both of these requirements were supported strongly across party, age and gender lines.
